

# Questions to ask your United Healthcare Service Representative Nutrition Counseling/Medical Nutrition Therapy with a Specialist (dietitian)

These questions are provided as a courtesy to help you determine if nutrition counseling may be covered by your insurance provider. Having these questions addressed by your insurance provider's member services does not guarantee coverage. In addition, you may be **required to obtain a doctor's order prior to your appointment**. Check the second page for more information on that process.

## **In Person Appointments**

## United Healthcare - Doctor's Orders Information

United Healthcare may require a Doctor's Order or sometimes called a Prescription for Service for most visits. (Exception - if you are considered overweight or obese a Doctor's Order is not needed.) **We require that the Doctor's Order is received prior to your first insurance appointment**. Please allow enough time before your appointment to gather that information from your doctor.

NOTE: UHC may have a preventive benefit for some Nutrition Therapy clients; but you must meet the overweight/obese criteria to access the preventive benefit.

\*\*\*If you do NOT fall in the overweight or obese category – we must have a Doctor's Order in order to bill for your visit.

#### **How to obtain a Doctor's Order**

Please call your primary care clinic/doctor and request a Doctor's Order.

"Doctor's Orders" may also be called a "Prescription for service"— so you may hear that term used as well.

### Why do you need this?

Many United Healthcare members seeing a Specialist require a doctor's order. Dietitians and Nutritionists are specialists.

United Healthcare requires a **medical code**: such as hypertension, high cholesterol, constipation etc. to cover your visit with a dietitian or nutritionist. Dietitians and nutritionists are not able to diagnose clients. We must have a Doctor's Order which includes a medical diagnosis code from a primary care provider so that we may file a claim United Healthcare.

You may contact your member services for more information on preventive benefits with your plan.

We are a private clinic and our Dietitians, Nutritionists and staff do not have access to your electronic health records where you see your primary care provider.

You will need to request that your clinic send us the required medical diagnosis codes using a Doctor's Order via FAX. (Fax # 651-305-0183)

#### What needs to be on the Doctor's Order?

- -Doctor's first and last name
- -Doctor's NPI number
- -Patient's first and last name
- -Patient's address
- -Patient's birthdate
- -Patient's diagnosis and ICD-10 code
